Tier 3 events can be held in accordance with published guidelines. Other risk factors may mean that an event is classified at a higher tier and will require approval to go ahead. • Public health advice will inform the approval of Tier 1 or Tier 2 events, based on the epidemiological conditions and broader restrictions at the time. • All events will be considered on application under the Public Events Framework and there are no pre-defined limits on the nature or size of events. • Private events such as weddings and funerals, routine religious gatherings and ceremonies, and public gatherings for ordinary, day-to-day activities are subject to the published restrictions limits and not covered by the Public Events Framework. The Stay Safe Directions (Victoria) and Restricted Activity Directions (Victoria) continue to apply to these day-to-day event activities and gatherings.
